MOTION TO CORRECT RECORD PURSUANT TO FRAP 10(e)

I, Robert L. Swinton Jr., defendant, hereby moves this Honorable Court for Correction of The Record, pursuant to FRAP 10(e)(1). Swinton is directly referring to trial records, which are directly material to arguments presented to The U.S. Second Circuit Court of Appeals. Swinton is requesting that this difference in the record be corrected, pursuant to FRAP 10(e)(2)(B).

Swinton declares, under penalty of perjury, that
Danielle Bowen was asked, "Do you know a man named Melvin
Frazier?" in trial. Bowen was also asked, "Do you know a man
named 'Roc'?" in trial as well. She answered both questions
"No". These questions are not reflected in the trial
transcripts. Moynahan was also shown a copy of the Federal
complaint of Melvin Frazier in trial, after she answered the
questions. The next documents that were shown to him in trial
were the police reports, where Bowen denied giving a statement
to the NYS Troopers.

In the transcripts, there are multiple jumbled 'misprints' that are capatolized lettering that makes no sense

of the conversation being had. The context of the conversations in trial were also changed in the transcripts as well. Swinton does not recall some of the conversations as transcribed.

The places of these "misprints' that changed the context of the testimony are as follows: Trial transcript ("TR.") pages 249 - 251 of Bowen's testimony. TR. page 361 (McDonald); TR. pages 382, 396, 403, 425, 426, 427, 428, 429 (Bernabei). These are vital areas in which these 'misprints' are incorparated into the trial transcripts. I am requesting that the transcripts be held unreliable or the record supplemented with the questions asked by Swinton, previously mentioned.

In sum, the defendant requests relief from these errors that will deprive him of a fair presentation to The Second Circuit Court of Appeals.
