MOTION TO QUASH SUBPOENA

U.S. Bank, for its Motion to Quash Subpoena, pursuant to Rule 45(2) of the Arkansas Rules of Civil Procedure, states:

- 1. Plaintiff filed a pro se Complaint against U.S. Bank on October 30, 2023.
- 2. Plaintiff has not obtained service of process on U.S. Bank pursuant to Rule 4 of the Arkansas Rules of Civil Procedure and no Affidavit of Service has been filed in this case.
- 3. On October 31, 2023, Plaintiff walked into the Conway branch of U.S. Bank and left a "Subpoena", copy of which is attached hereto as Exhibit "A".
 - 4. There is no time specified in the Subpoena for compliance therewith.
- 5. The Subpoena was not validly served on U.S. Bank as Rule 45(c) requires service of a subpoena "by the sheriff of the county in which it is to be served by his deputy or by any other person who is not a party and is not less than eighteen years old". Plaintiff is a party and therefore is not authorized to serve the Subpoena.
- 6. Moreover, such "service" is invalid as the Subpoena was not served on U.S. Bank's registered agent for service, or an officer of the corporation. See Ark. R. Civ. P. 4(f)(5) and Ark. Code Ann. § 23-48-327.

7. The Subpoena is not only invalid it seeks confidential information of a bank customer who is not a party to this case, is overbroad, unreasonable, oppressive and vague.

WHEREFORE, U.S. Bank respectfully requests that this Court quash the attached Subpoena.




